Beat 914 has consistently lead the district in robberies for a number of years. Reported robberies, 38 in total, thus far for the 2020 year are running parallel with the 2019 year. During the 2019 calendar year, 50 robberies were reported, compared to 47 in 2018. This was a dramatic decrease compared to 80 reported in 2017 and 94 in 2016.</p> <p>The reported number of car jacking's thus far in 2020 are 7. This represents a 133% increase compared to the same period for 2019 and 28.6% increase to 2018.</p>

Be as specific as possible.</i>	<p>During the 2020 calendar year, the listed boundaries has totaled 339 calls for service regarding shots fired and shot spotter incidents. This represents a 48.7% increase from the 2019 calendar year. The area indicated has also sustained 3 homicides and 17 shootings for the 2020 calendar year to date. This represents a 7% increase in both numbers.</p> <p>Citizens have brought forth concern during community conversations, beat meetings, and positive encounters throughout the year.</p> <p>To complex the issue, the gang conflict driving these shootings and homicides crosses district borders between the 7th and 9th Districts.</p>

Be as specific as possible.</i>	<p>4. <i>Who is / are the victim(s)?</i></p> <p>The true victims are the citizens living in the area that constantly feel unsafe due to the amount of shooting incidents plaguing this community. Business owners suffer financially as patrons fear coming to the area, thus hurting their businesses.</p> <p>The families of these victims suffer the loss of loved ones, causing severe and deep rooted feelings of loss and hurt. Sometimes, these family members become so irate, they in turn focus on their energies on seeking vengeance. These acts cause an endless circle of violence in these communities.</p> <p>Sadly, the actual victim(s) of these shootings do not realize their pain and suffering until it's too late. There has been a trend in which victims have used social media platforms while calling for acts of violence to take place upon them. Unfortunately these calls are answered far too often, and the outcome is a victim, now regretting the decision they made. The argument could be made these victims need mentoring, religion and structure in their lives, which should help them in seeing the error of their ways.</p>

Additionally, the 009th Abandoned Policing Officers will identify vacant lots and collaborate with city services to get the areas cleaned up as well as fenced in. Ensure that 311 requests are done to ensure all public lighting in the area is fixed.</p> <p><i>Enforcement response (if applicable):</i> 009th District Tactical teams will run directed missions during the identified peak times. The identified watches will determine the window of time when shootings spike on their watch. Request assistance from Community Safety Teams to address spikes in violence. Assigned SDSC Room Officers will conduct POD missions within these boundaries during peak hours. Any acts of violence can be quickly reviewed, and verified information can be dispatched to the patrol vehicles in real time.</p>

By employing deflection tactics (custom notifications), environmental tactics (vacant lot clean up, fencing and lighting) and enforcement tactics (tact team missions, beat integrity, and outside assistance from community safety teams) the 009 th District will attack the root cause on multiple fronts.

Be as specific as possible.</i>	<p>The area indicated has seen a drastic uptick in homicides and shootings. Year to date, there are 7 reported homicides representing a 250% increase. There are 28 documented shootings representing a 75% increase compared to the 2019 year. This same uptick is also noted in the calls for service regarding shots fired and shot spotter incidents. Year to date, there has been 474 calls for these services, compared to 194 in the 2019 year, representing a 69.3% increase.</p> <p>Citizens routinely refer to this area when discussing “hot areas” of crime within the District. To complex the issue, the gang conflict driving these shootings and homicides crosses district borders between the 8th and 10th Districts.</p>
