During the 01JAN20-05NOV20 timeframe a total of twenty eight (28) Aggravated Vehicular Hijackings occurred and a total of twelve (12) Vehicular Hijackings compared to 01JAN19-05NOV19 timeframe a total of fifteen (15) Aggravated Vehicular Hijacking and a total of nine (9) Vehicular Hijackings. The highest number of 2020 Aggravated Vehicular Hijackings and Vehicular Hijackings have occurred on Beat 1433.
