Four Offenders Charged with Murder of Chicago Police Officer



Offender #1: *Male juvenile, 16*

Charges: One (1) felony count – Murder - First Degree
One (1) felony count – Murder - Other Forcible Felony
Two (2) felony counts – Robbery - Armed with Firearm
One (1) felony count – Receive/Possess/Sell Stolen Vehicle
One (1) felony count – Burglary
One (1) felony count – Arson/Real/Personal Property >\$150
Issuance of Warrant



Offender #2: *Trevell Breeland, 19 - 7600 block of S. Bishop St., Chicago, Illinois*

Charges: One (1) felony count – Murder - First Degree
One (1) felony count – Murder - Other Forcible Felony
Five (5) felony counts – Robbery - Armed with Firearm
One (1) felony count – Receive/Possess/Sell Stolen Vehicle
One (1) felony count – Burglary
One (1) felony count – Arson/Real/Personal Property >\$150
One (1) felony count – UUW - Weapon - Felon, Poss/Use Firearm
One (1) misdemeanor count – Violate Order of Protection



Offender #3: *Joseph Brooks, 19 - 400 block of E. 80th St., Chicago, Illinois*

Offender #4: *Jakwon Buchanan, 18 - 7600 block of S. Bishop St., Chicago, Illinois*

Charges: One (1) felony count – Murder - First Degree
One (1) felony count – Murder - Other Forcible Felony
One (1) felony count – Robbery - Armed with Firearm
One (1) felony count – Receive/Possess/Sell Stolen Vehicle
One (1) felony count – Burglary
One (1) felony count – Arson/Real/Personal Property >\$150
One (1) felony count – UUW - Weapon - Machine Gun/Auto. Weapon
One (1) felony count – Aggravated UUW/Person/Loaded Firearm
Two (2) Issuance of Warrant

Court: Central Bond Court – 2600 S. California – May 10, 2023

Narrative: The above offenders were arrested and charged in connection to the murder and armed robbery of Chicago Police Officer Aréannah M. Preston, who was fatally shot in the line of duty on May 6, 2023, in the 8100 block of S. Blackstone (4th District). The offenders are also charged in connection to incidents that occurred on May 5-6, 2023, including armed robbery, burglary, motor vehicle theft, arson and weapons violations. The offenders were placed into custody and subsequently charged accordingly. No additional information is available at this time.
