About the crime:

In each of these incidents, 3-4 male Black offenders pull up in a stolen vehicle, at which time the offenders, wearing all black/dark colored clothing and black ski masks, exit the vehicle and approach the victim(s), brandishing handguns and demanding the victim's property. After taking the victim's property, the masked offenders routinely ask the victim(s) to give them the passcode to their cellphone. The offenders then return to the vehicle and flee. In one of these incidents, an offender shot a bystander who tried to intervene during the course of the robbery.

Sobre el crimen:

En cada uno de estos incidentes, 3-4 delincuentes se detienen en un vehículo robado, momento en el cual los delincuentes, vestidos completamente de negro/color oscuro y pasamontañas negros, salen del vehículo y se acercan a las víctimas, blandiendo pistolas. y exigir los bienes de la víctima. Después de tomar la propiedad de la víctima, los delincuentes enmascarados rutinariamente les piden a las víctimas que les den el código de acceso a su teléfono celular. Luego los delincuentes regresan al vehículo y huyen. En uno de estos incidentes, un delincuente disparó a un transeúnte que intentó intervenir durante el robo.
