**Special Commendation Award #8142112 is presented to Sergeants Terence Teahan, Kevin Rake, Detectives Daniel Burns, Joseph Fronczak, Chad Behrend, and Daniel Town, Police Officers David Marciano, Jay Tan, Simon Hall, and Patrick Wilkison**

- On 21 Dec 2020 a homicide occurred in which, a 33 year old father was gunned down when two individuals attempted to commit a vehicular hi-jacking against him.
- Search warrants were executed on all involved vehicles and property, of which aided detectives to prove that the offender was in the area of the homicide and was associated with additional vehicular hijackings.
- The above case was presented to the Cook County State's Attorney's Office who in turn approved charges of First Degree Murder, Felony Murder, numerous counts of Aggravated Vehicular Hijacking, and Possession of a Stolen Motor Vehicle.

**Department Commendation Award #8142205 is presented to Police Officers Phoebe Flores and David Waite**

- Officer Waite observed a driver, of a Pontiac Grand Prix, stick a handgun out of the sunroof while driving; at which time Officer Waite and Officer Flores curbed the vehicle.
- The offender was placed into custody after a pursuit, where Officer Waite and Officer Flores positively identified offender and offender's handgun.
- The Cook County Felony Review was contacted and charges of Armed Habitual Criminal and Aggravated Assault to a Peace Officer were approved along with a parole violation warrant.
